Property Appraiser.

Comments: The tile roof covering was replaced in 2003. The roof permit was

confirmed and the permit number is 03-4001747. The flat roof covering was replaced in 2021. The roof permit was confirmed and the permit number is 21-3000089. This roof was verified as not meeting the building

code requirements outlined on the mitigation affidavit.

3. Roof Deck Attachment: Other

Comments: Inspection verified a roof deck composed of lightweight concrete gypsum

panels supported by steel bar joists.
